Membership Classifications

Full: Includes access to Golf, Tennis, Pool, Fitness center, Clubhouse and all events

Social: Includes access to Tennis, Pool, Fitness center, Clubhouse and all events

**All memberships include a \$150 food spending minimum per quarter*

**Initiation & Dues are based on the age of the primary member, which is the eldest spouse*

**Dues increase when the eldest spouse moves into the next age bracket*

**Both spouses have equal membership but only 1 vote per membership*

**New Anchorage residents must redeem the New Resident rates within 6 months of house closing*

**Legacy is defined by the child, grandchild or stepchildren of a current Senior Full Member or the substantial equivalent who has been in good standing for 15 continuous years or more*

**Full memberships and monthly dues are subject to taxes.*

**Payment plans and deferred initiation fees are available. All payment plans will incur a 7.5% fee.*

**Capital Fees: All membership classifications are subject to a monthly capital fee, with the exception of Clergy and House classifications. Non resident members will pay 33.3% of monthly capital fees.*

Corporate Memberships

**Pay a one-time, upfront initiation fee*

**Includes 2 primary memberships either golf or social*

**Only 1 member is granted voting rights and that person must be declared*

**Add up to 3 additional memberships for 10% each of the current corporate initiation fee*

**Allowed to switch out members for 10% of the initiation fee at any time*

**All members, primary and secondary, are subject to pay any club assessment and/or dues increase*

**All members, primary and secondary, are responsible for monthly dues*

**Current members are welcome to upgrade/change their memberships to a corporate membership.*

They can apply their paid initiation payments to the \$25,000 Corporate rate

**Proof of a legitimate corporation is necessary to qualify*

**All applications are subject to approval from the Board of Directors*
